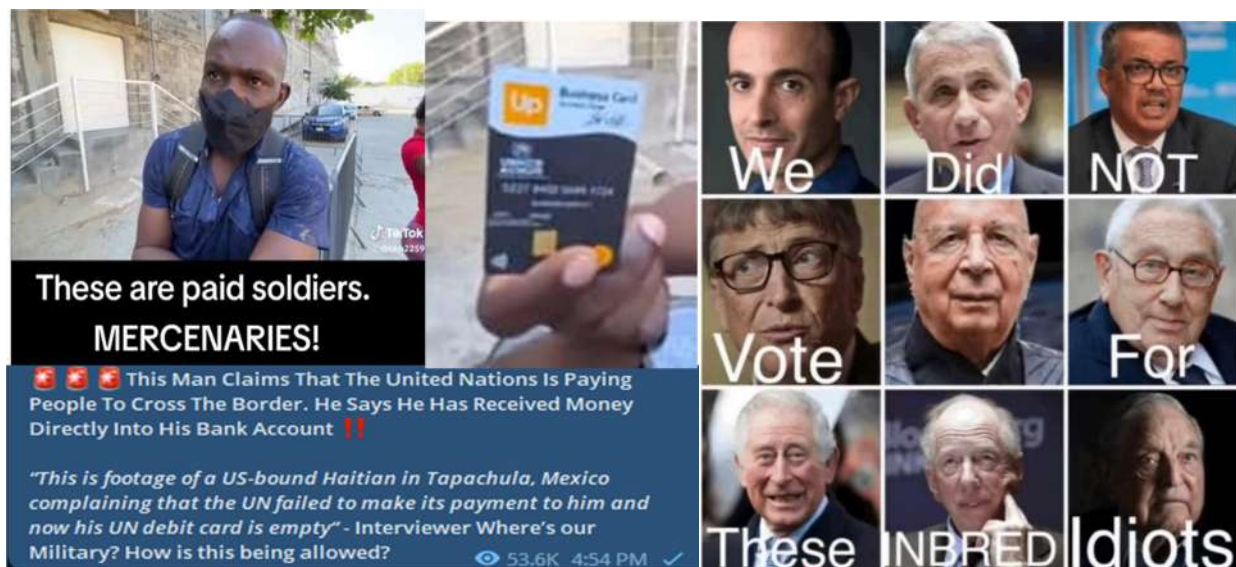

The American People living upon the land in Nevada county², California, no longer Consent to being governed by the Synagogue of Satan³ directed Rothschild-Rockefeller-United Nations, Khazarian Mafia, controlled: “UNITED STATES®,” the “STATE OF CALIFORNIA,” or the “COUNTY OF NEVADA” foreign corporate dictatorships. The People of Nevada county are dedicated to peaceful, non-violent social and political change of our county governance back to a guaranteed Republican Form of Government.

Patriotic Americans have for decades been warning us about **a hidden hand controlling our nation** [JFK Secret Societies Speech (full version), main speech at 6.00 mins - <https://www.youtube.com/watch?v=zdMbmdFOvTs>], which included the great American, Louis Thomas McFadden (July 25, 1876 - October 1, 1936), who was a Republican member of the United States House of Representatives from Pennsylvania, serving from 1915 to 1935 that brought criminal charges against the Federal reserve Crime cartel that have to this day never seen the light of day (See notes on Page 41 concerning McFadden). A reminder: In California, as well as in all state republics of the American Union, it is not the public servants of any “Branch” of state Government, however transcendent they imagine their authority, who are supreme, **but it is the People**; and, to suppose that any government officer or employee may violate the fundamental law, is to affirm that the deputy is greater than his principal; that the servant is above his master; that the representatives of the People are superior to the People themselves; that the men (and women) acting by virtue of delegated powers may do, not only what their powers do not authorize, but what they forbid; is not only a most grievous insult to the American Body Sovereign, i.e., the American People, **but is the very essence of the word: Treason.** [see: Declaration of Independence (A. D. 1776); Articles of Confederation (A. D. 1778); Constitution for the United States of America (A. D. 1787), Sixth Article, clause 3, and the Preamble to the "Bill of Rights", and First, Second, Fourth, Fifth, Sixth, Seventh, Ninth and Tenth Amendments (A. D. 1791); California Constitution (A. D. 1849), Article I, Sections 2 and 21; Government Code §100(a) also see: Federalist No. 78 (A. D. 1788)]

Fundamentally, both the actual de jure law of the original The United States of America and the municipal rules and codes of the UNITED STATES® municipal services corporation and its sub-chartered corporations (the latter being unlawfully instituted without the people’s authority) could function adequately to provide Peace, Prosperity, and abundance for all Americans today. However, the fundamental problem that we have identified in our research of government going back 200 years, is that foreign usurpers banned from American government forever, including 1.4 million active, Crown BAR Franchised Attorneys (and other foreign agents), have infiltrated all government layers across America at every level. These constitutionally-banned foreign agents (BAR Attorneys) illegally monopolized the practice of law and banking across America since the 1870’s, and so egregiously manipulated and altered the meaning of our Words, to directly benefit Crown Franchised attorneys, corporations and their principals, at the expense **of all the American People.**¹¹ Over the last several decades, these foreign agents replaced our organic governments with foreign corporations masquerading as our original governments. Through semantic deceit, these foreign agents duped the American People into appearing in court cases as legal fictions (i.e. persons, decedents, residents, legal fictions, etc.), which enabled BAR Attorneys since the late 1930’s to treat the American People **as if they were subject to** private Corporate rules and codes (intended for corporate fictions not men and women) and foreign corporations, including those masquerading as our lawful governments.

While this Mixed War has been waged against the American People by BAR Attorneys, the people were not taught about this monumental legal scam in their schools, and they were deliberately distracted by Bread and Circuses!

"If the American people ever allow private banks [FEDERAL RESERVE SYSTEM] to control the issue of their currency, first by inflation, then by deflation, the banks and corporations that will grow up around them will deprive the people of all property until their children wake up homeless on the continent their Fathers conquered."

It should be noted that today, the UNITED STATES®, the "[Rothschild] THE STATE OF ISRAEL"® Corporation [Company number **OE027515**], and all similar situated "COUNTRIES" are nothing but foreign commercial corporations (not countries) created under the CROWN [Corporation of London or Registered on the SEC] and are masquerading as if they were legitimate We the People, governments. These Corporations are in the business of farming their captive humans on each of their respective plantations to maximize profit for their shareholders [which are Black Nobility owners of the CROWN and VATICAN]¹². This same pattern and practice applies to at least 191 additional Crown – Vatican operated corporation-plantations each masquerading as if they were a sovereign nation with free and fair elections [Look up SIC Code 8888, example: CANADA: <https://www.sec.gov/cgi-bin/browse-edgar?action=getcompany&CIK=0000230098&owner=exclude&count=40&hidefilings=0>].

In this reality that we now find ourselves in, Sovereign Americans who created government for the sole purpose of protecting and defending our unalienable Rights, are now in **the mind's eye of Attorneys and government actors running the UNITED STATES® plantation system**, through it and its sub-chartered corporations, nothing more than serfs and slaves; our job is to serve foreign corporations masquerading as Governments. **More clearly stated, our role has been reduced to one where the people work to fund government.**

Yet, no so-called Court Administrator [aka Judge] ever discloses the true nature of the business that the so-called courts are truly engaged in, which is a blatant act of constructive fraud [See: **COURT REGISTRY INVESTMENT SYSTEM** [CRIS] for a better understanding of what is really going on in the so-called Courts, see footnote]¹³.

Let us spell out the problem: Our nation has been usurped by actors pretending to be our original, organic Governments that are engaged in sedition and treason.

Today, the ongoing usurpation of the united states of America is actively being aided and abetted by a substantial number of the Officers of the UNITED STATES® municipal corporation and those of similarly situated at every so-called COUNTY and STATE Government Office operating across America that **have no compliant Oath of Office**. Many of these actors are constitutionally banned foreign agents (including all BAR attorneys, see references to TONA below¹⁴].

Every one of these Officers and employees is acting as a trustee of a Public Trust and has a Fiduciary duty to serve and protect the American peoples’ unalienable Rights, which duty they have clearly abandoned and abused. The term for this dereliction of duty is **Treason**.

The Public Record testifies to the fact that most of the Actors claiming to be government employees and Officers, are by virtue of both the organic laws of the land, and their own foreign municipal rules and codes, banned from ever taking a government Office in America [ref. It is also a matter of public record that nearly all so-called Government officers and employees operating across America today do not have the mandated Oath of Office required for them to take office [from the county dog catcher to the STATE OF CALIFORNIA Governor, up to and including the entire Biden regime¹⁵ federal government apparatus], and as a result, these people are not permitted to act as any government officer, act in office, or collect a paycheck [Example: employees and Officers are blatantly violating California Government Code §§ 1360-1369, 1770(i), 1879 State of California Constitution Art. Based on the foregoing, until live agents acting **as employees and officers** of the UNITED STATES®, STATE OF CALIFORNIA, the COUNTY OF NEVADA [hereinafter CON] and all similarly situated governments across the united states of America **get their houses in order, comply with the organic laws and their own rules and codes**, we the people listed below **will no longer consent to:**

(1). **Being governed** by live agents of foreign, criminal, commercial enterprises, **masquerading as if they are de jure¹⁶ American governments or lawfully created agencies authorized by the Authority of the American People, when they are not;**

Occupation of the united states of America by The Synagogue of Satan

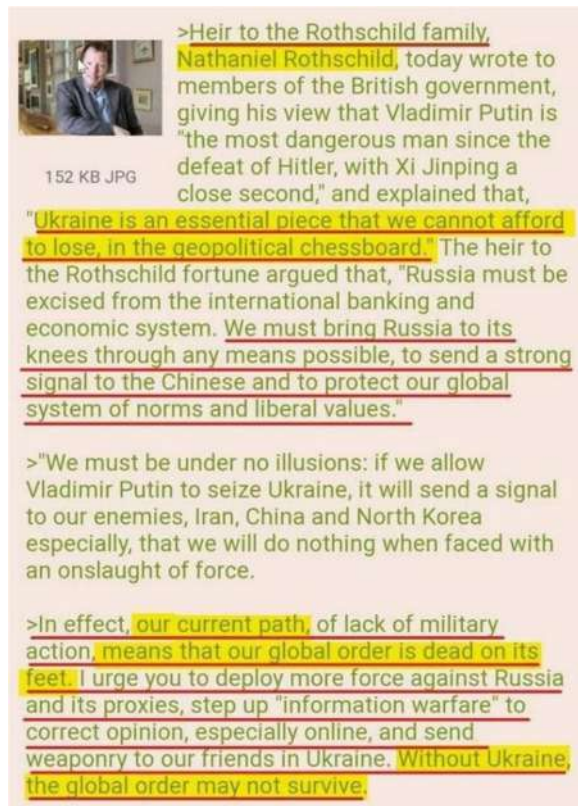

The truth is, the united states of America has for more than one hundred and fifty years been directly steered by KM captured governmental services corporations waging endless Wars to benefit the long-term strategic goals of the KM who are hell bent on creating a One World Government that they rule. It should be plainly obvious to all Americans that America **has no legitimate reason to be involved in the Ukraine war**. unlawfully enforced on the American people by BAR attorneys in counterfeit courts for foreign KM-banking interests. More plainly stated, this is being done to thief the credit belonging to the Sovereign American People²⁴ *held at the United States Treasury in the name of every American.*

The Public Record testifies that the Rothschild-KM unlawfully control all Western Nations either directly through their agents running private corporations masquerading as legitimate governments, and through their control of the money powers.

their **Oath of Office**, and specifically adhere to The United States for America Constitution at Art. IV, Section 4. Government actors impersonating Government are liable for court martial [10 U.S.C. §§ 906 (a)(3), 252, 253]. Actors masquerading as Government actively engaged in overthrowing The United States of America are liable also per the Revised codes and statutes²⁶ requiring court martial.

It is self-evident that Article IV, Section 4 requires all those claiming to be government to protect and to defend America's Borders, which does not mean allowing for our gates on the southern border to be welded open or paying Billions for the protection of Ukraine's borders while deliberately allowing for America to be destabilized by an ongoing invasion.

If governments' actors do not protect our Borders and take all measures necessary to prevent **Domestic Violence** from occurring in our nation, then the American Body Sovereign has a duty to take all necessary steps to provide safeguards for our own safety and to protect ourselves and our communities from **treasonous individuals** claiming to be public servants.

The ongoing destruction of the fabric of American society, including the war on our children by pedophiles, Luciferians - Satanists, the ongoing mass invasion of our Borders (and the borders of Europe), and the deliberate destruction of our nation's infrastructure, is the fruit of the KM that took control of the organs of our nation after the Civil War. states: “defend the Constitution of the United States **against all enemies, foreign and domestic.**”

It is a fact that live agents acting for these foreign government services corporations are openly engaged in blatant **Mixed War** against the American People and have long been subverting the rule of law across America, the republic state of California, and in Nevada county (California).

The Public Record testifies that individuals masquerading as public servants are unquestionably **aiding and abetting** the overthrow of our nation by adhering to policies that violate our standing organic laws and customs (e.g., allowing into our country un-vetted mass immigration without any checks and balances).

The united states of America is controlled (occupied) by live agents of the KM created UNITED STATES® municipal services Corporation, operating as a corporate Democracy for DC and UNITED STATES® possessions. It is not the “republican in form” de jure Government guaranteed to the People and the states, and it has no legitimate authority over the American People, yet it is controlling almost the entire population. How is this possible?

Based on all of the foregoing and our extensive research, it is self-evident that the District of Columbia municipal services corporation, called the **UNITED STATES®**²⁸, its fifty STATE sub-chartered municipal services corporations, and its 3,143 sub-chartered COUNTY municipal services corporations, are clearly not the original “Republican Form of Government” our Founding Father’s created to **serve the American Body Sovereign**.²⁹ Instead, they are **Rothschild**³⁰ (CROWN-VATICAN) created [RUN], foreign, de facto corporations masquerading as if they are an American Government, and **therefore**, the American People no longer need to consent or agree to any of their demands, orders, bills, edicts, so-called laws, etc.

The Public Record testifies that the UNITED STATES® is undeniably a corporate municipal **democracy** created and maintained under its corporate U.S. Constitution, plagiarized from the original de jure Constitution **for** the United States America³¹ (September 17, A. D. 1787), deceptively styled as the CONSTITUTION **OF** THE UNITED STATES, and adopted post A. The Public Record testifies at *63C Am. Jur. 2d: Public Officers and Employees, § 247* “As expressed otherwise, the powers delegated to a public officer are held in trust for the people and are to be exercised on behalf of the government or of all citizens who may need the intervention of the officer. [1] Furthermore, the view has been expressed that **all public officers**, within whatever branch and whatever level of government, and whatever be their private vocations, **are trustees of the people**, and accordingly **labor under every disability and prohibition imposed by law upon trustees relative to the making of personal financial gain from a discharge of their trusts**. [2] That is, a public officer occupies a

fiduciary relationship to the political entity on whose behalf he or she serves. [3] and owes a fiduciary duty to the public. [4] It has been said that the fiduciary responsibilities of a public officer cannot be less than those of a private individual. [5] **Furthermore, it has been stated that any enterprise undertaken by the public official who tends to weaken public confidence and undermine the sense of security for individual rights is against public policy.** Fraud, in its elementary common law sense, is deceit, and this is one of the meanings that fraud bears [483 U.S. 372] in the statute. See *United States v. Dial*, 757 F.2d 163, 168 (7th Cir. 1985) includes the **deliberate concealment of material information** in a setting of fiduciary obligation. A public official is a fiduciary toward the public, including, in the case of a judge, the litigants who appear before him, and if he deliberately conceals material information from them, he is guilty of fraud. *McNally v. United States*, 483 U.S. 350 (1987).”

The Public Record testifies that no evidence has been presented by live agents of COUNTY OF NEVADA (hereinafter “**CON**”) municipal services corporation, that the sovereign People of Nevada county did, at any time in the past, authorize their own enslavement under foreign, inferior municipal services corporations [Pursuant to our Notice Issued and received by CON on November 29, A.D. 2022].

The Public Record also testifies that public servants of the previous de jure government of the Nevada county at some time breached their constitutional Oath of Office and fiduciary Duty to the People, and upon doing so, **deliberately** concealed this transition from de jure to de facto government from the People. The Public Record testifies that a Republican Form of Government is guaranteed to all three-thousand one-hundred and forty-three (3,143) de jure counties of these united States of America, pursuant to the organic Constitution for the United States of America at Article IV, Section 4. The American People living in each of California's fifty-eight de jure counties now have a solemn Duty and Obligation to reseat their own county governments, as republican in form, unincorporated county government; and to throw-off all foreign globalist (KM-controlled) live agents and corporations masquerading as if they are de jure California government entities or agencies.

Three years following the Treaty of Compromise, Pope Francis issued a Motu Proprio (see below) to command **all those operating under the Offices of The Holy See / Vatican State** to cease engaging in criminal activity and to operate within the confines of their Corporate charters. Both sides would benefit from knowing the KM Bankers' Strategy [by Kuhn Loeb partner Otto Kahn] that they have long been relying on for their ruling of the world under their planned One World Government dystopia:

In a candid moment after World War I, Kuhn Loeb partner Otto Kahn explained that the bankers "remake" the world by creating artificial conflicts and determining the outcome [the modern fake left-right paradigm for example].

Otto Kahn, (1869-1934) was a partner with Jacob Schiff and Paul Warburg in America's most influential investment bank Kuhn Loeb.

Thus, it is worth recalling what he said about the bankers' strategy.

In his book Geneva versus Peace (A. D. 1937), the Comte de St. Aulaire, who was the French ambassador to London from 1920-24, recalled a dinner conversation with Otto Kahn which took place shortly after World War I.

He asked why bankers would back Bolshevism, a system supposedly inimical to private ownership, Otto Kahn explained that the bankers create apparent opposites to "remake the world" according to their specifications:

"You say that Marxism is the very antithesis of capitalism, which is equally sacred to us. It is precisely for this reason that they are direct opposites to one another, that they put into our hands the two poles of this planet and allow us to be its axis. These two contraries, like Bolshevism and ourselves, find their identity in the International.

"These opposites ... meet again in the identity of their purpose and end in the remaking of the world from above by the control of riches, and from below by revolution.

"Our mission consists in promulgating the new law and in creating a God, that is to say in purifying the idea of God and realizing it, when the time shall come. We shall purify the idea by identifying it with the nation of Israel, which has become its own Messiah. The advent of it will be facilitated by the final triumph of Israel."



“Our essential dynamism makes use of the forces of destruction and forces of creation but uses the first to nourish the second...Our organization for revolution is evidenced by destructive Bolshevism and for construction by the League of Nations, which is also our work.”

Otto Kahn also exemplifies how these bankers create reality by controlling what passes for culture. Kahn financed many movies and virtually created the New York's Metropolitan Opera. He was responsible for introducing Stanislavski, Nijinski, the Abbey Players, the Moscow Art Theater, and practically every other important personage and event in the most vigorous era of American theatrical history. He subsidized, sponsored, and had close relationships with Toscanini, Caruso, Chaliapin, Pavlova, Pirandello, Eugene O'Neill, Paul Robeson, Grace Moore, and hundreds of other artists whose names are now part of that history.

Frederick T. Gates (business advisor to John D. Rockefeller, Sr.) said: *“We shall not try to make these people or any of their children into philosophers or men of learning or of science. We are not to raise up among them authors, orators, poets, or men of letters. We shall not search for embryo great artists, painters, musicians....”*

American Sovereigns and intelligent state Citizens are difficult, if not impossible, to govern. It is just a fact. The more independent and intelligent you are, the more likely you will know the issues and be aware when you are being given **deliberate misinformation**.

Now ask yourself, how did education in America transform from a system that imparts knowledge where we had a near 100% literacy rate and the highest education standards in the world, to one that uses behavior modification techniques (gender confusion bullshit, Marxism, common core, etc.) to influence the attitudes and beliefs of those passing through it?

Comm. Code 9307(h) and ARS § 47-9307H]. They do know that UNITED STATES® jurisdiction only applies to things created by the UNITED STATES® and does not ordinarily apply to the American People. This presumption is false and is based on constructive (and actual) **Fraud**.

Everything that governments' live agents do today is based on that fraudulent presumption; and the presumption that a valid contract exists between the parties to any controversy. There is no valid contract. Everything is based on fraud [fraud and constructive Fraud].



All government employees (Federal, State, County, and City), who **have not** taken and subscribed to the constitutionally mandated Oath (Constitution for the United States of America, Article I, clause 3; also 4 U.S.C. § 101) and do not have the Fidelity or Performance Bond required by the Common Law, are engaged a seditious conspiracy, insurrection, and treason, whether they know it or not (18 U.S.C. § § 2381-2385).

which at this time includes sending near limitless funds to perpetuate the Ukraine, the KM war against Russia, in a futile attempt to destroy the KM's ancient enemy, the Russian people. Clearly America's real enemies are not Russia, China, Cuba, North Korea, or any other foreign nation. The American People's true enemy has been waging their silent Mixed War against the People of America from behind America's gates for over the last one hundred and fifty years. The de jure governments across America have long been supplanted by private, for-profit, foreign municipal services corporations at every level of government, including our cities, counties, states, and federal; and, they all operate as sub-chartered corporations created under the corporate authority of the UNITED STATES® municipal government services corporation, which is in the District of Columbia.

On examination of all government operating across America, we find CROWN-franchised BAR agents (constitutionally-banned attorneys) have supplanted all of our original organic governments for foreign corporations [See: Corporate Nation⁴¹] and have captured what were once three distinctive, separate Branches of Government into one well-oiled machine, controlled by BAR Attorneys who literally run the entire so-called Government apparatus across every city, county, and state, such that all the so-called Government apparatus across the nation now moves in lockstep to a Rothschild-UNITED NATIONS One World Government drum-beat instead of tracking real local interests of the American People!

What is also now apparent since the A. D. 2008 so-called bank bail-outs [The Emergency Economic Stabilization Act of 2008] is the blatant rigging of the entire United States of America so-called “Judiciary,” where virtually every outcome in every so-called Court Case across the entire United States of America just so happens to be in near perfect lockstep with the desired outcome of the globalist’s agenda, which has included legitimatizing more than 22+ million home thefts by the Banks in Court-sanctioned Banking Heists, authorizing the theft of the 2020 election, and now protecting the Pharmaceutical companies and other perpetrators of a Global Genocide who have been pedaling poisonous vaccines as a COVID 19 Cure. If one looks into court cases involving challenges to Bank Fraud Closure Scams⁴², the Trump impeachments, the Mar-a-Largo Raid, federal court cases challenging the Biden Regime to provide constitutionally-valid oaths of office, the UNITED STATES SUPREME COURT [D-U-N-S® Number 111477469] handling of the Brunson cases, court cases brought by Mike Lindell’s legal team and others challenging the 2020 elections, including Kari Lake’s election case in Arizona, and now the recent flurry of anti-Trump cases, one realizes the entire BAR-controlled legal system operating across America is rigged by bought-and-paid-for BAR attorneys. These BAR attorneys are part of KM-STATE municipal government services corporations and the AMERICAN BAR system, which are, in fact, franchised under the KM-CROWN Temple Inns of Court system “legal” scam. The entire legal judicial system operating in America is a private, for-profit, illegal monopoly.

Looking back into history, we can now see that America **has not been run in accordance with America’s original, organic constitutional republic law foundations** for over 200 years. while contaminating victims with **graphene-oxide** and other biomarkers that will make the Vaxxed prone to being bio-hacked remotely.⁴³

Since the initiation of the Plandemic three years ago, Members of the Nevada county assembly have relentlessly petitioned actors of the so-called CON government for “a redress of grievances.” We realized that our guaranteed republican in form government has not existed in our county for more than 100+ years, and employees and Officers acting in Government across California did not have the Oath of Office (or Bond) that is required in the STATE OF CALIFORNIA Constitution before an employee or officer can take office, operate in Office, or collect a paycheck.⁴⁴

The Public Record testifies that the CON government services corporation unlawfully and illegally supplanted our original Nevada County, organic county government (created in 1851 as a republican in form government) in the aftermath and confusion of the CROWN manufactured so-called “Civil War.”

The Public Record testifies that the major factor that has allowed our enemies to get away with supplanting our original governments for KM-owned corporations; the effective enslavement and impoverishment of ordinary Americans; and, the ongoing occupation of our nation over the last 150 years, was the KM’s introduction of a national education system, while capturing and controlling the entire mainstream media since the late 1800’s. The so-called national education system was weaponized against the American People from the outset. Learn the difference between you (live man name Last, First, M) the agent and the PRINCIPAL (FIRST LAST Strawman)]. Following is **black-and- white proof**⁴⁵ (more cites in the footer section) provided via U. S. Supreme Court

rulings, The Law of Nations, and State Supreme Court decisions, etc., that operating as if you are the UNITED STATES (FIRST LAST) citizen status (that nearly all Americans have proudly adopted) is a status of voluntary servitude and is the antithesis of what is implied by virtue of being an America National (state National) or having an American birthright Status:

It is evident that they [U.S. citizens] have not the political rights which are vested in Citizens [Nationals] of the states. They are not constituents of any community in which is vested any sovereign power of government. Their position partakes more in the character of **subjects** than of citizens. They are subject to the laws of the United States [or Canada as applicable] but have no voice in its management. If they are allowed to make laws, the validity of these laws is derived from a government in which they are not represented. Mere citizenship they may have, but the political rights of [state] Citizens [Nationals] they cannot enjoy [see: e.g., *People v. De La Guerra*, 40 Cal. 311 @ 342 (1870)].

“.... It will be sufficient to observe briefly, that the sovereignties in Europe, and particularly in England, exist on feudal principles. That system considers the prince as the sovereign, and the people as his subjects; it regards his person as the object of allegiance and **excludes the idea of his being on an equal footing with a subject, either in a court of justice or elsewhere.** That system contemplates him as being the fountain of honor and authority; and from his grace and grant derives all franchise, immunities and privileges; it is easy to perceive that such a sovereign could not be amenable to a court of justice or subjected to judicial control and actual constraint. It was of necessity, therefore, that suability, became incompatible with such sovereignty. Besides, the prince having all the executive powers, the judgment of the courts would, in fact, be only monitory, not mandatory to him, and a capacity to be advised, is a distinct thing from a capacity to be sued. The same feudal ideas run through all their jurisprudence, and constantly remind us of the distinction between the prince and the subject.”

No such ideas obtain here [speaking of America]: at the Revolution, the **sovereignty devolved on the People; and they are truly the sovereigns of the country**

U.S. citizens can murder their unborn children. “The unborn are not included within the definition of “person” as used in the 14th Amendment.” *Roe v. Wade*, 410 U.S. 113 (1973). Note: The U.S. Supreme Court overturned *Roe v. Wade* in *Dobbs v. Jackson Women's Health Organization*, 597 U.S. ____ (2022). Writing for the court majority, Justice Samuel Alito said that the 1973 *Roe* ruling and repeated subsequent high court decisions reaffirming *Roe* “must be overruled” because they were “egregiously wrong,” the arguments “exceptionally weak” and so “damaging” that they amounted to “an abuse of judicial authority.”

“Where crime is committed with impunity by any class of persons, society, so far as they are concerned, is reduced to that condition of barbarism which compels those unprotected by other sanctions to rely upon physical force for the vindication of their natural rights. There is no other remedy, and no other security.” *United States v. Rhodes*, 27 Federal Cases 785 @ 794 (1866)

“The 14th Amendment defines and declares who shall be citizens of the United States, and protects only such rights as are rights belonging to **persons** as citizens of the United States, and not rights belonging to [the People] as [C]itizens [Nationals] of a state.” *United States v. Susan B. Anthony*, 24 Fed. Cas. 829 (1873)

“Residents, as distinguished from citizens, are aliens who are permitted to take up a permanent abode in the country. Being bound to the society by reason of their dwelling in it, they are subject to its laws so long as they remain there, and, being protected by it, they must defend it, although they do not enjoy all the rights of citizens. They have only certain privileges which the law, or custom, gives them. Permanent residents are those who have been given the right of perpetual residence. They are a sort of citizen of a less privileged character, and are subject to the society without enjoying all its advantages. Their children succeed to their status: for the right of perpetual residence given them by the State passes to their children.” - **The Law of Nations**, Emer de Vattel, Book 1, Chapter 19, § 213, pg. 87



[realm], but they are sovereigns without subjects (unless the African slaves among us may be so-called) and have none to govern but themselves; the **Citizens of America** are equal as fellow Citizens, and as **joint tenants in the Sovereignty.**" *Chisholm v. Georgia*, 2 Dallas (U.S.) 419 @ 469 (1793)

The truth of the matter is that **the American People are sovereign**, but over time they were stealthily and cunningly deceived into accepting UNITED STATES® corporate citizen, slave status and operating as if they were the TRUST-name created by the filing of the Birth Certificate.

When we look at the STATE OF CALIFORNIA corporation municipal codes, we discover that the legislature did, in fact, codify the American People's true status in its Government Code: **All sovereignty resides in the American People.** [see: e.g., Cal. Government Code §§ 100(a), 11120, 54950].

The Secret Treaty of Verona signed on November 22, A. D. 1822, and published in the U.S. Senate Congressional Record in A. D. 1916, spells out why the High Contracting Powers desperately wanted to stamp-out the idea that a People can self-govern (without rule by parasites) and that the people can declare themselves Sovereign. The Treaty spells out the measures the Crown used to retake America, as they did do by 1871.⁴⁶

The concept of sovereignty stands on its own.

"...at the Revolution, **the sovereignty devolved on the People**; and they are truly the sovereigns of the country, **but they are sovereigns without subjects**...with none to govern but themselves; the Citizens of America are equal as fellow Citizens, and as joint tenants in the sovereignty." *Chisholm v. Georgia*, U.S. (2 Dall.) 419 @ 454 (1793)

The People of this State, as the successors of its former sovereign, are entitled to all the rights which formerly belonged to the King by his prerogative. Through the medium of their Legislature, they may exercise all the powers which, previous to the Revolution, could have been exercised either by the King alone, or by him in conjunction with his Parliament; subject only to those restrictions which have been imposed by the Constitution of this State or of the United States. *Lansing v. Smith*, 21 D. 89, 4 Wendel 9 (1829) (New York Court of Appeals).

"The very meaning of 'sovereignty' is that the decree of the sovereign makes law." *American Banana Co. v. United Fruit Co.*, 213 U.S. 347 (1909).

"'Sovereignty' means that the decree of sovereign makes law, and foreign courts cannot condemn influences persuading sovereign to make the decree." *Moscow Fire Ins. Co. of Moscow, Russia v. Bank of New York & Trust Co.*, 294 N.Y.S. 648, 662, 161 Misc. 903.

The **American People's** true **Prerogative Rights, Immunities, and Authority** in relation to **all Public Servants** (federal, state, county, and city) can be summarized as follows:

Prerogative Notice: The Servant does not charge the Master

The **American People**, eo nomine,* as individual constituent Members of the American Body Sovereign, have an unalienable Right to free access to all judicial tribunals and public offices in every State in the Union without being charged any "filing fees" or "court costs." [see: Declaration of Independence (A. D. 1776); Articles of Confederation (A. D. 1778); Constitution

for the United States of America (A. D. 1787), Sixth Article, clause 3, and the Preamble to the "Bill of Rights," and First, Second, Fourth, Fifth, Sixth, Seventh, Ninth, and Tenth Amendments (A. D. 1791); see also: *Crandell v. Nevada*, 73 U.S. 35 @ 44 (1868)].

“Sovereignty itself is, of course, not subject to law, for it is the author and source of law; but in our system, while [some] sovereign powers are delegated to the agencies of government, sovereignty itself remains with the People, by whom and for whom all government exists and acts.” *Yick Wo v. Hopkins*, 118 U.S. 356 @ 370 (1886)

**Eo nomine* is a Latin legal term meaning "by that name." The United States Supreme Court has used the term in the context of sovereign immunity. Also see: *People ex Rel. Bank of Commerce v. Commissioner of Taxes* [67 U.S. 620 (1862)] for earlier discussion on the use of the term: *eo nomine*.

Prerogative Notice: The Servant does not judge the Master

In *Alden v. Maine* [527 U.S. 706 (1999)] Justice Souter, for the dissent, wrote that according to **natural law**, a sovereign, like a state, could not be sued in their own court based on the undisputable Fact that by their sovereign authority, the court was created.

"The immunity of a truly independent sovereign from suit in its own courts has been enjoyed as a matter of absolute right for centuries. Only the sovereign's own consent could qualify the absolute character of that immunity." [*Nevada v. Hall*, 440 U.S. 410 (1979)]. "In reciting the prerogatives of the Crown, Blackstone, whose works constituted the preeminent authority on English law for the founding generation, underscored the close and necessary relationship understood to exist between sovereignty and immunity from suit:"

‘And, first, the law ascribes to the king the attribute of sovereignty, or pre-eminence Hence it is, that no suit or action can be brought against the king, even in civil matters, because no court can have jurisdiction over him. For all jurisdiction implies superiority of power’ 1 W. Blackstone, *Commentaries on the Laws of England* 234-235 (1765), quoted in *Alden v. Maine*, *supra*.

Prerogative Notice: The Servant does not tax the Master

The constituent Members of the American Body Sovereign, i.e., the American People are constitutionally-exempt **“nontaxpayers.”** Congress clearly understands it has no constitutional authority to tax the Members of the American Body Sovereign, and for the purposes of determining any tax liability, does not assume to deal with constitutionally-exempt “nontaxpayers;” and, that such “nontaxpayers” are neither the subject nor the object of the provisions of Internal Revenue Code [see: e.g., *Long v. Rasmussen*, 281 F. 236 @ 238 (1922); *Gerth v. United States*, 132 F. Supp. 894 (1955); *Botta v. Scanlon*, 288 F. 2d 509 (1961); *Economy Plumbing & Heating Co. v. United States*, 470 F. 2d 585 @ 589 (1972)].

Prerogative Notice: The Servant does not interfere with the Master’s Right to freely Travel on and Use the Public Right-of-Way to Conduct the Master’s Private Business

Although not explicitly mentioned in the federal Constitution [see: Ninth and Tenth Amendments], the right to travel freely from one state to another is a basic right under the Constitution. The nature of the federal union and of constitutional concepts of personal liberty unite to require that all Citizens be free to travel throughout the length and breadth of the United States, uninhibited by statutes, rules, or regulations that... burden or restrict this movement. The **right to travel freely is secured against interference** from any source whatever, whether governmental or private. And the **constitutional right** to travel between



states implies a correlative constitutional right to travel within a state [see: Declaration of Independence (A. D. 1776), Vol. 1 United States of America Public Statutes at Large, pg. 1-3; Crandall v. Nevada, 73 U.S. 35 @ 44 (1868); California Jurisprudence (Third Edition), Vol. 13, § 238].

The **right of transit** through each state, with every species of property known to the Constitution of the United States, and recognized by that **paramount law**, is secured by that instrument to each Citizen, and **does not** depend upon uncertain and changeable ground of mere comity [In Re Archy, 9 Cal. 47 (California Supreme Court 1858)].

Prerogative Notice: The Servant is personally liable to the Master for all damages caused by the Servant's failure to protect and defend the Master's property Rights.

The **sovereignty** of the state of California **resides in the People** thereof. [Constitution of California (A. D. 1849), Article I, Section 2; see also: Government Code § 100(a)]

As a general rule men and women have a **natural right to do anything**, which their inclinations may suggest, if it be not evil in itself [malum in se], and in no way impairs the rights of others. Governmental power only extends to restraining each one in freedom of his or her conduct, so as to secure perfect protection to all others from every species of danger to person, health, and property; that each individual shall be required to use his or her own as not to inflict injury upon his or her neighbors; and these seem to be all immunities which can be justly claimed by one portion of society from another, under government of constitutional limitation [In Re Newman, 9 Cal. 502 (California Supreme Court 1858)]

The **right of property antedates all constitutions**. Everyone has the right to enjoy his or her property and improve it according to his or her own desires in any way consistent with rights of others. [see: People v. Holder, 53 C.A. 45 (1921)].

Key Results: In the first 24-hours after application, both mRNA-1273 and BNT162b2 caused neither functional disturbances nor morphological abnormalities. After 48 h, expression of the encoded spike protein was detected in ventricular cardiomyocytes for both mRNAs. At this point in time, mRNA-1273 induced arrhythmic as well as completely irregular contractions associated with irregular as well as localized calcium transients, which provide indications of significant dysfunction of the cardiac ryanodine receptor (RyR2). In contrast, BNT162b2 increased cardiomyocyte contraction via significantly increased protein kinase A (PKA) activity at the cellular level.

Conclusions and Implications:

Here we demonstrated for the first time, that in isolated cardiomyocytes, both mRNA-1273 and BNT162b2 induce specific dysfunctions that correlate patho-physiologically to cardiomyopathy. Both RyR2 impairment and sustained PKA activation may significantly increase the risk of acute cardiac events.

The **common law of England**, so far as it is not repugnant to or inconsistent with the Constitution of the United States, or the Constitution or laws of this State, is the rule of decision in all the courts of this State.

The Public Record testifies that every so-called COURT styled as a SUPERIOR COURT OF CALIFORNIA operating across California is a foreign, private, for-profit business illegally operating on the 58 counties of the California state. They all rely on **simulated legal process (fraud)**, legal sophistry, and trickery to extend corrupt, foreign Jurisdiction over the Californian People. These foreign businesses are Babylonian Commercial Courts (Banks), and in essence, are **dry docked** out of the District of Columbia UNITED STATES® municipal services corporation (operating under CROWN-VATICAN and UNIDROIT⁴⁸ Roman Civil Law and Babylonian Law Merchant / Uniform Commercial Code) over California. These RICO Courts are openly engaged in extortion and Human Trafficking, in violation of state, federal, and international law, including Trump era Executive Order 13818. legitimate state Constitution, as can be validated by comparing the style of every state court operating in California to that specified under California Government Code 68076. It should be clear to all that if the Constitution never authorized an Office to exist, or a court to exist, there can be no legitimate Office to fill. No judge or magistrate can act for a court that was never legitimately created! This should help everyone realize all government is made up of actors of offices that we never created by our organic constitutions!

These ongoing Racketeer Influenced Corrupt Organizations [RICO] have directly been funding KM Central Banking criminal syndicate operations (Federal Reserve, BIS, other Central BANKS, IMF - Crime Cartels); the monetary outflows of which these operations are used to foment the KM's ongoing multi-generational war on mankind (like in the Ukraine and Gaza) and their obsession with creating a One World Government to control all of the World (which is their plan after killing off 90% of the people by any means necessary⁴⁹).

The Public Record testifies that the 170,000+ so-called "practicing" BAR attorneys operating in California do not have the mandated license to practice law, per State of California authorities [Business and Professions Code §§ 6067, 6068(a)], and all government actors operating across California, from the dog-catcher to the Governor, are unequivocally actors impersonating Government and operating in violation of Federal Criminal Statutes **10 U.S.C. §§ 906 (a)(3)**, 252, 253, which Federal crime is subject to a **military court martial** [see also, California Government Code §§ 1360-1369, 1770(i), 1879 State of California Constitution Art. XX, Section 3, Calif. Government Code 68076, Business and Professions Code §§ 6067, 6068(a); Civil Code §§ 1567, 1689(b)(1), violations include 15 U.S.C. §§ 1-2; 18 U.S.C. §§ 242-242].

The Public Record testifies that employees and officers of the foreign COUNTY OF NEVADA (d.b.a. NEVADA COUNTY) [hereinafter CON] municipal government services corporation have failed to produce any historical evidence, lawfully requested by the People of Nevada county, that authorized live agents of the CON municipal government services corporation to supplant Nevada county's original, organic, de jure Government, which was created as a **guaranteed** Republican Form of Government in A. The Public Record testifies that the live agents of the CON are operating in violation of the actual laws of our land, published in the Revised Statutes of the United States of America and the STATE OF CALIFORNIA's own de facto corporate charter (1879), municipal rules and codes, Article XX, Section 3; Government Code, §§ 1360-1369, 1770; and sections from the U.S. Code].

This above topic is addressed thoroughly in the following section of this document, which includes a presentation by Shelagh McFarlane called "What is really going on with government."

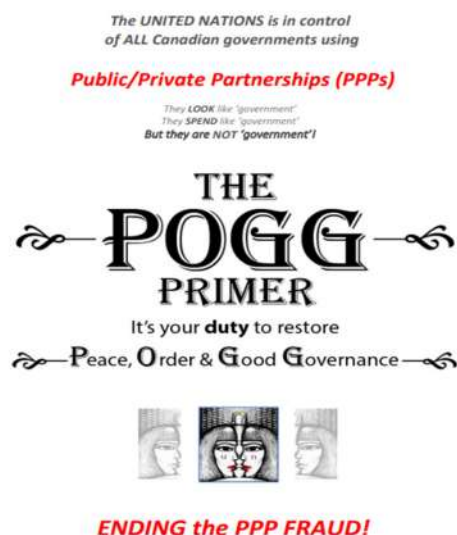

Revised Statutes of the United States are still law of the land.

Revised Statutes are still valid federal law (see: 42 U.S.C. § 1987 - <https://www.law.cornell.edu/uscode/text/42/1987>)

Commercial Code § 9307(h)], is still law of the land; and, that it banned all foreign agents from our Government from when our nation was founded through Titles of Nobility Provisions. For example:

Revised Statutes of the United States [page 380], SEC. 2165. **An alien may be admitted to become a citizen of the United States in the following manner, and not otherwise: First.** He shall declare on oath, before a circuit or district court of the United States, or a district or supreme court of the Territories, or a court of record of any of the States having common-law jurisdiction, and a seal and clerk, two years, at least, prior to his admission, that it is bona fide his intention to become a citizen of the United States, **and to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and, particularly, by name, to the prince, potentate, state, or sovereignty of which the alien may be at the time a citizen or subject.** **Fourth.** In case the alien applying to be admitted to citizenship has borne any hereditary title or been of any of the orders of nobility in the kingdom or state from which he came, he shall, in addition to the above requisites, make an express renunciation of his title or order of nobility in the court to which his application is made, and his renunciation shall be recorded in the court.

Other provisions of the Revised Statutes of the United States include the following:

Revised Statutes of the United States SEC. 5332. Every person guilty of treason shall suffer death; or, the discretion of the court, shall be imprisoned at hard labor for not less than five years, and fined not less than ten thousand dollars, to be levied on and collected out of any or all of his property, real and personal, of which he was the owner at the time of committing such treason, any sale or conveyance to the contrary notwithstanding ; **and every person so convicted of treason shall, moreover, be incapable of holding any office under the United States.**

Revised Statutes of the United States SEC. 5333. Every person, owing allegiance to the United States and having knowledge of the commission of any treason against them, who conceals, and does not, as soon as may be, disclose and make known the same to the President or to some judge of the United States, or to the governor, or to some judge or justice of a particular State, is guilty of misprision of treason, and shall be imprisoned not more than seven years, and fined not more than one thousand dollars.

Revised Statutes of the United States SEC. 1979. Every person who, under color of any statute, ordinance, regulation, custom, or usage, of any State or Territory, subjects, or causes to be subjected, any citizen of the United States or other person within the jurisdiction thereof to the deprivation of any rights, privileges, or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, suit in equity, or other proper proceeding for redress.

Revised Statutes of the United States, SEC. 5508. If two or more persons conspire to injure, oppress, threaten, or intimidate any citizen in **the free exercise or enjoyment of any right jure or intimidate or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or if two persons go in disguise on the highway, or on the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured,** they shall be fined not more than five thousand dollars and imprisoned not more than ten years ; and shall, moreover, be thereafter ineligible to any office, or place of honor, profit, or trust created by the Constitution or laws of the United States.



HOUSE CONCURRENT RESOLUTION NO. 23

[Submitted by Mr. Bacon]

Resolved by the Senate (the House of Representatives concurring), That there shall be compiled, printed with illustrations and bound as may be directed by the Joint Committee on Printing, ten thousand copies of the Madison Debates of the Federal Convention, together with the Declaration of Independence, the Articles of Confederation, the Constitution, the instructions to the Delegates to the Federal Convention, the instruments of ratification of the States, and the texts of the amendments to the Constitution, and other relevant and pertinent historical documents for distribution in the year 1926 in commemoration of the one hundred and fiftieth anniversary of the Declaration of Independence of the United States of America, to the end "that government of the people, by the people, for the people shall not perish from the earth," of which three thousand copies shall be for the use of the Senate and seven thousand copies for the use of the House of Representatives.

Adopted, May 10, 1926.
